## PRODUCT DESCRIPTION

Broad spectrum perfume-free, water resistant and sweat resistant SPF50 sunscreen for professional use to protect the skin against the harmful effects of UVA, UVB and UVC rays.

## WHERE TO USE

Outdoor workers exposed to UVA & UVB sun rays and workers exposed to UVC rays created during industrial processes, such as arc welding etc.

## INSTRUCTIONS FOR USE

- Apply liberally to clean, dry skin 15 minutes before UV exposure
- Re-apply every 2-3 hours, or more frequently if sweating or washing

**Caution:** Applying an insufficient amount of product reduces the protective performance. Over-exposure to the sun is a serious health threat. Even sunscreen with a high SPF does not offer full protection against UV rays and does not replace the need to use/wear appropriate personal protective equipment and clothing. Avoid excessive UV exposure. Keep babies and young children out of direct sunlight and wear protective clothing. Avoid eye contact.

## SHELF LIFE

This product has a shelf life of at least 30 months from the date of manufacture when stored unopened at room temperature.

## QUALITY ASSURANCE

SC Johnson Professional products are manufactured in facilities which follow cosmetic Good Manufacturing Practice (cGMP) requirements.

All raw materials used for production undergo a thorough quality control process before being used for manufacturing in SC Johnson Professional's high quality products.

All finished goods are subject to intensive quality testing before being shipped out to our customers.

## PRODUCT SAFETY ASSURANCE

### Skin Compatibility Test

Clinical dermatological tests have been conducted to assess the skin compatibility of the product using voluntary test persons in enclosed and repeat application models as well as on sensitive skin and skin treated with UVA radiation (Human Photo Patch Test). These tests, as well as in practical use, have proven that the product has very good compatibility with normal and sensitive skin. Skin compatibility expert reports are available upon request.

Declared safe for intended use on children over 6 months & adults.

### Ultra Sensitive Testing

Using a HRIPT model over a 3 week period on 50 people, Stokoderm® Sun Protect 50 PURE demonstrates excellent skin compatibility, especially for people suffering from allergies, sensitive skin and atopic eczema.

### Toxicological Approval

The product has been independently assessed for human toxicity and product stability. It is declared safe for intended use, meeting all relevant regulatory requirements.

## COMPATIBILITY TESTS

### Rubber Production Process Compatibility

In testing conducted by the Deutsches Institut für Kautschuktechnologie (DIK) in accordance with DIN EN ISO/IEC 17025, the use of Stokoderm® Sun Protect 50 PURE in rubber production process does not influence the cohesive strength of rubber.

## EFFICACY TESTS

### Assessment of UVA-PF In vitro

Determined according to COLIPA guideline March 2011 confirms a UVA protection (Colipa ratio <3).

### UVB Efficacy Test in vivo

Using the International Standard for determining the sun protection factor (ISO 24444:2010) the SPF was determined along with the claim for water resistance.

### UVC Efficacy Test in vitro

Using a modified COLIPA Guideline method, the trapezium rule was used to confirm that the product provides a distinctly lower transmission of UVC range >250nm.

SPECIAL NOTE: UV protection creams even with high SPF, do not offer full protection against UV rays and do not replace the need for using/wearing appropriate personal protective equipment and clothing.

### Water Resistance Test

Determination of the SPF factor according to ISO 24444:2010 (E) before and after water application to volunteers in a spa pool for 2 x 20 minutes, confirms an SPF50 and that this sun protection is water-resistant.

### Sweat Resistance Test

Determination of the SPF factor according to ISO 24444:2010 (E) was performed on volunteers before and after exposure to high temperature conditions (Sauna - Temperature 80°C for 10 minutes). Results confirm an SPF50 that is sweat resistant in accordance to COLIPA Guideline for Evaluating Sun Product Water Resistance, 2005.
